Project Title: Routine Inspections, Monitoring, and Maintenance at Rifle, Colorado, Disposal and Processing Sites

Location: Rifle, Colorado, Disposal and Processing Sites

Proposed Action or Project Description:

Conduct routine activities to include inspections, monitoring, and maintenance. The sites would be visually inspected on an annual basis, at a minimum. Monitoring activities would include aerial surveys, general surveying, ground and surface water sampling, and System Operation and Analysis at Remote Sites work. Other proposed activities would include well maintenance, well redevelopment, downloading data from data loggers or similar instrumentation, transducer maintenance and calibration, telemetry equipment maintenance and calibration, and unscheduled well repairs. Maintenance would be noninvasive activities such as equipment repair, fixing signs, installing or repairing gates and fences, regrading parking areas and road repair, erosion control and soil stabilization, vegetation monitoring and management, rangeland health assessments, beneficial reuse projects, evaporation pond liner inspections and minor repairs, vehicle use. Performance of the baseline aerial survey and potential future surveys would occur on an as-needed basis. No aviation activities would commence until required Flight Safety Plans are approved by a certified DOE Aviation Manager and permission is received from the LM site manager. Follow-up aerial surveys would require new Aviation Safety Plans approved by a certified DOE Aviation Manager and LM site manager.

All proposed activities would be performed by Legacy Management Support contractor staff or a subcontractor.
