

- A. The purpose of this modification is to extend the Period of Performance for Contract Line Items 11 & 12 from 9/30/2021 to 1/31/2022, obligate funds in the amount of \$7,400,000.00 to the contract, and correct the total amount obligated to CLIN 2 listed in Modification 678 to read \$3,202,282,846.46.
- B. Funds in the amount of \$4,400,000.00 are hereby obligated to CLIN 00011, increasing it from \$475,000.00 TO \$4,875,000.00.
- C. Funds in the amount of \$3,000,000.00 are hereby obligated to CLIN 00012, increasing it from \$775,000.00 to \$3,775,000.00.
- D. Paragraph B.4 entitled "Limitation of Funds" is hereby revised to increase the total amount of funds obligated to the contract by \$7,400,000.00, changing it **FROM:** \$6,580,144,657.67 **TO:** \$6,587,544,657.67. The total obligated amount of \$6,587,544,657.67 is allocated as follows:
