# ORDER GRANTING BLANKET AUTHORIZATION TO IMPORT AND EXPORT NATURAL GAS FROM AND TO CANADA

DOE/FECM ORDER NO. 4780

**DECEMBER 22, 2021** 

### I. <u>DESCRIPTION OF REQUEST</u>

On December 3, 2021, Uniper Trading Canada Ltd. (Uniper Trading Canada) filed an application with the Office of Fossil Energy and Carbon Management (FECM) of the Department of Energy (DOE) requesting blanket authorization under section 3 of the Natural Gas Act (NGA)¹ for the authority summarized in the list below. The applicant requests the authorization for a two-year term beginning on January 11, 2022.² Uniper Trading Canada is a Canada limited liability company with its principal place of business in Calgary, Alberta, Canada.

- 1. Import natural gas from Canada by pipeline at any point on the border between the United States and Canada
- 2. Export natural gas to Canada by pipeline at any point on the border between the United States and Canada

Import and export authority was requested for up to a combined total volume equivalent to 365 billion cubic feet (Bcf) of natural gas.

#### II. FINDING

DOE has evaluated the application to determine if the proposed import and/or export arrangements meet the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under NGA section 3(c), imports and exports of natural gas, including liquefied natural gas (LNG), from or to any country with which the United States has entered into a free trade agreement (FTA) requiring national treatment for trade in natural gas and the import of LNG from other international sources are deemed to be consistent with the public interest.<sup>3</sup> DOE must grant such applications without modification or delay.<sup>4</sup> The authorization sought by Uniper Trading Canada meets the NGA section 3(c) criteria, and, therefore, is deemed to be consistent with the public interest.

### ORDER

Pursuant to section 3(c) of the NGA, it is ordered that:

A. Uniper Trading Canada is authorized for the activity described in the list below. This authorization shall be effective for a two-year term beginning on January 11, 2022, and extending through January 10, 2024.

- 1. Import natural gas from Canada by pipeline at any point on the border between the United States and Canada
- 2. Export natural gas to Canada by pipeline at any point on the border between the United States and Canada

The applicant is authorized to import and export up to a combined total volume equivalent to 365 Bcf of natural gas.

B. **Monthly Reports:** With respect to the imports and/or exports authorized by this Order, Uniper Trading Canada shall file with the Office of Regulation, Analysis, and Engagement, within 30 days following the last day of each calendar month, a report on Form FE-746R indicating whether imports and/or exports have been made. Monthly reports must be filed whether or not initial deliveries have begun. If no imports and/or exports have been made, a report of "no activity" for that month must be filed. If imports and/or exports have occurred, the report must provide the information specified for each applicable activity and mode of transportation, as set forth in the Guidelines for Filing Monthly Reports. C. The first monthly report required by this Order is due not later than February 28, 2022, and should cover the reporting period from January 11, 2022 through January 31, 2022.
