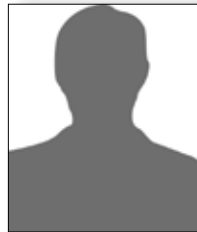

Higher Education Research Experience Program. He lives in Knoxville and is interested in environmental and public health issues.

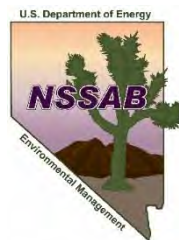

# What is the EM SSAB?

- Chartered in 1994 under FACA to involve local citizens more directly in DOE EM cleanup decisions
- There is one charter for the EM SSAB – currently eight local boards organized under the EM SSAB umbrella charter
- These eight local boards are brought together routinely at the EM SSAB Chairs meetings, where the EM SSAB is able to speak in one voice



- Made up of representative members, not necessarily experts
- Focus on stakeholder values
- DOE receives independent input and focus on transparency to build trust

## Purpose of FACA

- Ensure that advice by advisory boards/committees is objective and accessible to the public
- Formalize process for establishing, operating, overseeing and terminating advisory boards
- Create the Committee Management Secretariat
- Require that boards advise and recommend, not decide and implement

## Benefits of FACA

- Transparency and participation improves citizens' trust in government
- FACA requirements lend credibility to the boards' advice





# FACA by the Numbers

- ~1,000 federal advisory committees in existence at any time
- ~65,000 committee and subcommittee members at any time
- ~60 executive departments and agencies that sponsor committees each year
- ~1,000 reports issued each year
- ~7,000 meetings held each year

- Requires a charter outlining the committee's mission and specific duties
- Allow for open access to committee meetings and operations
  - Meetings must be accessible to the public and announced in the Federal Register
  - Committee documents must be maintained and made available for public inspection
- Maintain a “fairly balanced” membership
- Provide an opportunity for Public Comment
- Violations?





# Consequences of a FACA Violation

## Good News

- No criminal penalties
- No civil or monetary penalties

## Bad News

- Litigation
- Time-consuming
- Meetings could be prohibited
- Use of group's advice and/or supporting documents could be prohibited
- Undermines the credibility of our program
- Erodes trust

**Membership of Wind Turbine Guidelines Advisory Committee violates FACA**

WASHINGTON D.C. (January 17, 2008) – [In a letter submitted today](#), environmental and wildlife groups<sup>1</sup> called on Secretary of the Interior Dirk Kempthorne to revamp the membership of the Wind Turbine Guidelines Advisory Committee of the U.S. Fish & Wildlife Service. The current membership violates the Federal Advisory Committee Act (FACA), which governs the establishment of federal advisory committees.

# DOE Responsibilities under FACA

- Ensure compliance with FACA, regulations, DOE Guidance, and all related agency policies
- Approve agendas for each Board meeting
- Call, attend, and adjourn every Board meeting (includes sub-committees)
- Maintain required committee records (e.g., costs, minutes, membership)
- Prepare Federal Register notices
- Prepare annual report to the CMO summarizing Board activities
- Nominate members for appointment
- Ensure all ethical standards are met by Board members
- Ensure that meetings are held at a reasonable time and place, accessible to the public

# Member Responsibilities

- Attend regular meetings and learn about the site's EM cleanup mission
- Provide recommendations at the request of EM management
- Work collaboratively and respectfully with other Board members
- Avoid techniques such as “bargaining” and acquiescence simply to avoid conflict and reach agreement
- Avoid responding directly to public comments
- Don't use your title or represent the board outside of a meeting
- Report if an outside entity is attempting to influence your decisions
- Focus on the Board's mission – collaboratively establishing a work plan
- Notify the DDFO of any potential or perceived conflict of interest



EM SSAB members are not subject to the same federal ethics regulations as federal employees and Special Government Employees (SGEs).

- As a matter of policy, however, DOE asks that you:
  - Refrain from any use of your membership, which is, or gives the appearance of being, motivated by the desire for private, professional, or financial gain;
  - Recuse yourself from decisions and discussions related to real or perceived conflicts of interest, act impartially, and avoid the appearance of impropriety; and
  - Seek immediate guidance, beginning with the DDFO, if you are offered anything of value such as a gift, gratuity, loan, or favor in connection with advisory board service.

## RECOMMENDATION TO REVISE THE MEMBER APPOINTMENT PROCESS

### Background

The work of the DOE-EM Site-Specific Advisory Board (EM SSAB) is in support of Department of Energy (DOE) programmatic missions focused on environmental cleanup of post-war nuclear and chemical contamination. At each of our respective sites, that work has been substantially and adversely impacted over the course of the past few years, in part, because of the length of time it is now taking to get appointment letters approved for individual Board members to participate. It has hamstrung Board abilities, at each site, to fulfill DOE goals for development and incorporation of public policy advice concerning the nature of cleanup and many other issues. For example, often potential members apply and later withdraw their applications due to extended delays in the appointment process. Boards have had to delay providing advice or recommendations due to a lack of membership, coupled with the loss of Board or Committee chair leadership while they wait for appointment approval. Reduced Board membership has also limited the development of institutional knowledge, so necessary at sites whose cleanup missions will extend decades into the future. In some cases, experienced and informed members are handicapped by a year or longer gap between their terms because they lack the special and immediate access to information on emerging issues that active members receive. More significantly, the extended approval process, which has often resulted in depleted Board rosters, has reduced Board legitimacy, and eroded public confidence in the DOE, including attracting complaints from community organizations and negative media coverage.

Examples of negative impacts specific to each site are attached to this recommendation.

### Recommendation

The EM Site-Specific Advisory Board (EM SSAB) believes that the Department of Energy (DOE) should substantially revise the membership approval process to ensure that the continuity of Board and Committee activities is protected and remains intact such that there is no disruption of stakeholder involvement and input as per each Board's respective chartering agreements and operating rules.

While the larger effort to comprehensively revise the SSAB membership approval process is pursued by the Designated Federal Officer for the EM SSAB and in order to further enable stakeholder participation at their respective sites during this endeavor, the EM SSAB recommends:

1. The membership review and approval process should include all reasonable activities necessary to prevent lapsed memberships. A lapsed membership is defined as: a membership held by a member in good standing whose term has expired but has not reached the six-year limit.
2. The site manager should be empowered to temporarily extend the terms of lapsed members in good standing or to temporarily appoint other qualified members to replace lapsed members until a new membership package is approved.<sup>1</sup>
3. The DOE should publish the review and appointment process and then take feedback from the public and EM SSAB members. The published information should identify which elements are required by the Federal Advisory Committee Act, the General Services Administration, and the EM SSAB charter, and which elements are internal to the DOE, as well as where those DOE policies and procedures can be found.

Two members of the public were present.

### **Liaison Comments**

**Mr. Mullis** – Mr. Mullis told members that OREM has finished the demolition work at the Biology Complex and all the material has been disposed of. He added there is still slab work to do, although it is already underway, and there is still sampling to be done once the slabs are removed. He said OREM is on track to having that project completed in the fall and to be able to turn the property over to Y-12 so they can start building their new facility. He said that project was the start of the major work at ORNL and Y-12. There are several facilities at ORNL and Y-12 have a lot of OREM crews working currently. He said at ORNL, crews are mainly at the old “Reactor Row area and the “Isotope Row” area. He said OREM is doing a lot of deactivation work in those facilities for demolition. At Y-12, OREM is doing deactivation work in Beta-1 and Alpha-2, and work is also underway at Building 9213, which is an old criticality experiments facility. He said OREM is on track to demolition that facility sometime in early 2022 and is on track to demolition Beta-1 in late 2022 or early 2023.

Mr. Mullis next told members that OREM is finishing up work at ETTP. He told members that TVA and Kairos Power in May announced plans to build a demonstration reactor at the site, and if that comes to fruition – and it looks like it will – it will be about a \$100 million investment that will create about 55 jobs and the facility will construct a 185 acre parcel. He said there are a couple of additional transfer packages for much smaller parcels that have gone to Congress for Congressional notification.

Regarding waste disposal capacity, Mr. Mullis told members that OREM is on track to submit the new disposal cell draft ROD to EPA and TDEC in July. He said once that is submitted, OREM plans to have some additional public outreach to go over elements such as waste acceptance criteria, site selection, and wastewater discharge limits.

Regarding the budget, Mr. Mullis said the President just released his budget request, and for Oak Ridge, it’s one of the best President’s requests in recent years. He said it would allow OREM to continue progress at the current pace.

**Ms. Jones** – None.

**Mr. Czartoryski** – None.

### **Presentation**

Ms. Lohmann introduced Dave Adler, presenter for the evening’s topic, ETTP Groundwater Remedies Update.

Mr. Adler began his presentation by giving new members an overview of the location being discussed, explaining that it generally refers to the area in the northwest corner of the reservation. He said OREM is getting close to the time when it should make decisions regarding groundwater at ETTP because at this point crews have completed with buildings that needed to be remediated and are nearing completion on soil that needed to be remediated. Much of the site has already been completely cleaned up. He said OREM’s general commitment has been that it would begin making decisions regarding groundwater after the sources of contamination are cleaned up and are no longer degrading the situation. In addition, he said, companies are beginning to come to the site and it would



be helpful for planning purposes to know subsurface remediation plans at the site. He added that OREM has also collected enough data to where it is ready to make a decision. There have been monitoring wells at the site for about 30 years, so there is a lot of data.

He said OREM will likely be seeking public input on groundwater remedy selection over the next year.

Next, Mr. Adler gave members an overview of the two main areas of the ETTP site and detailed key plans and dates in the groundwater decision timeline. He said the K-31/K-33 area used to contain two uranium enrichment facilities, and those facilities have been removed and the soil cleaned up entirely. The property has been through certification by the State and the EPA as ready to reuse, and it has been sold to the Community Reuse Organization of East Tennessee (CROET). He said CROET may soon sell the property to an energy company that would like to develop some test facilities there. Next, Mr. Adler told members the Main Plant area – located southeast of the K-31/K-33 area – was the part of the site with most of the groundwater contamination. He told members there are additional areas at the ETTP site, but they generally are devoid of groundwater contamination. OREM will address any remaining areas after first addressing the K-31/K-33 area and the Main Plant area.

Mr. Adler then detailed highlights of investigation activities that have taken place in the K-31/K-33 area of ETTP since 1987 and said the data indicates that the water at the K-31/K-33 site is in good shape. He said most of the samples come back at measured values below drinking water standards. He added that the general goal for the site is bring the site's water quality to the point that groundwater restrictions would not be necessary and said the site is almost at that point, even without intervention. He said a little bit of chromium is present at some locations, as is a little bit of nickel. He said that although a formal proposal has not been made, it's likely that the solution will be to allow natural attenuation while monitoring. He said OREM is working with EPA and TDEC to finalize the necessary documentation.

Shifting focus to the Main Plant Area, Mr. Adler told members there had been a lot of solvent materials, typically called halogenated or halocarbon solvents, released in that area. He explained these solvents had been used for degreasing operations and had leaked down into the soil, and because they are heavier than water, ultimately made their way down into the rock below the water table.

Mr. Adler then gave members an overview of OREM's usage of monitoring wells at the site.

Next, he told members that OREM had completed a feasibility study to explore various technology alternatives that could be used to address the groundwater issues under the Main Plant Area. Options explored included lowering electrically powered probes into the ground to heat the ground up and drive the volatiles off; bioremediation, or systems that involve taking advantage of naturally occurring bacteria in the groundwater that can actually metabolize the contaminants; as well as conventional pump and treat operations. He said the preferred approach currently seems to be bioremediation. He added that given the complicated nature of the issue, OREM has worked with EPA and TDEC to develop an interim remedy.

He then gave members a visual overview of the groundwater issues in the Main Plant Area.

Mr. Adler told members in summary that OREM is finishing the surface and soil work at ETTP and beginning redevelopment of the site. He said OREM has put in a significant number of wells in the course of a few decades of groundwater studies, and while they may still put in more, they are at the point where they are ready to start taking that information generated and try to use it to advance cleanup activities at the site, although, he said, that is a conclusion that must be reached with everybody – OREM, experts, regulators, and the public.

After the presentation, board members asked the following questions:

- Ms. McCurdy asked what types of organisms would be involved if bioremediation were used.
  - Mr. Adler said they would be using bacteria that occur naturally in the water column, so new organisms would not have to be introduced.
- Mr. Tapp asked whether surface water aquatic toxicity standards are taken into account.
  - Mr. Adler said they are. He said they must not only keep people safe, which is done by cleaning up the groundwater and preventing people from drinking contaminated groundwater, but they must also protect the stream, which is done by meeting standards in the stream that are protective of the aquatic biota. He added that it appears from the monitoring in the creek where the plume is daylighting that just a foot or so from the bank, readings are well below any level of concern..

She added that the proposed edits resulted from experiences over the past year and would provide more flexibility.

Ms. Lohmann asked for a motion to approve updates to the board bylaws as amended.

  - a. **6.9.21.3 Motion to approve updates to approve board bylaws as amended**  
Motion made by Mr. Shields and seconded by Ms. Jones. Motion passed unanimously.
4. Ms. Lohmann reminded members that officer elections would occur during the October 2021 board meeting, and she asked members to consider serving as board executive members. She emphasized the added learning opportunities inherent with the positions. Mr. Tapp added that four of the current five members of the executive committee will be going into their final terms, so new members are needed.
5. Ms. Lohmann gave members background information about charges requested of the board by headquarters. The first of the charges is to develop a best-practice white paper that DOE can use to augment existing practices and expectations for future outreach activities. The second charge is to identify

SSAB 10-year expectations and guiding principles that can be used as a complex-wide framework for DOE's EM interaction with stakeholders and communities.

EM & Stewardship – Ms. Jones said committee members discussed whether a recommendation was warranted for Waste Disposal Capacity and decided one was not warranted at the time. Mr. Tapp added that the issue group is still undecided on whether to make a recommendation.

## INTRODUCTION

The Oak Ridge Site Specific Advisory Board (ORSSAB) is a federally appointed citizens' panel that provides advice and recommendations to the U.S. Department of Energy (DOE) Oak Ridge Office of Environmental Management (OREM). The group was formed in 1995 and is chartered under the EM SSAB Federal Advisory Committee Act Charter. The board's mission statement is as follows:

*The mission of the Oak Ridge Site Specific Advisory Board is to provide informed advice and recommendations concerning site specific issues related to the Department of Energy's Environmental Management Program at the Oak Ridge Reservation. In order to provide unbiased evaluation and recommendations on the cleanup efforts related to the Oak Ridge site, the board seeks opportunities for input through collaborative dialogue with the communities surrounding the Oak Ridge Reservation, governmental regulators, and other stakeholders.*

The board is composed of up to 22 members, chosen to reflect the diversity of gender, race, occupation, views, and interests of persons living near the DOE Oak Ridge Reservation. Members are appointed by DOE and serve on a voluntary basis, without compensation. The board currently consists of members from four counties: Anderson, Knox, Loudon, and Roane. Non-voting representatives to the board include personnel from OREM, the U.S. Environmental Protection Agency Region 4, and the Tennessee Department of Environment and Conservation. These representatives advise the board on their agency's policies and views. Two non-voting student representatives also serve on the board to represent the viewpoints and concerns of area youth. The board strives for consensus in reaching decisions and conducts business under its "Bylaws and Operating Instructions," which incorporate the principles of *Robert's Rules of Order*.

## FY 2022 ORGANIZATION

Each year the board holds a planning meeting to determine how best to address its mission and what its committee structure should be. A summary of that meeting is available on the ORSSAB website at [www.energy.gov/orssab](http://www.energy.gov/orssab). The board's organizational structure is shown in Figure 1. As allowed by ORSSAB Bylaws, other committees may be formed as needed during the year to address specific issues.

## Frequently Asked Questions: Issue Groups

### What do issue groups do?

- Issue groups create the original drafts of recommendations that will be considered for sending to DOE. Issue groups discuss ORSSAB topics, usually as articulated in the board's annual work plan, to formulate the board's potential recommendations. Group members select an issue manager from among the group's members, and that issue manager compiles the group members' thoughts into a cohesive draft recommendation.

### How often do issue groups meet?

- Issue groups may meet at the discretion of the group members, **however**, group meetings are not required. Generally, group discussions are carried out via email. For effective email discussions, members should ensure all other members of the group are included in the **To:** or **CC:** address lines in email correspondence for the discussion. ORSSAB staff and DOE should also be included in all email correspondence for the discussion.

### Can staff help issue groups draft recommendations?

- Actual recommendation directives must come from the members, however staff can help with background information and discussion.

### What issue group topics are there?

- ORSSAB issue groups are broken down into monthly presentation topics as listed in the board's annual work plan. For example, OREM Program Outreach (October 2018 topic), Ongoing Efforts to Assure Sufficient Waste Disposal Capacity (November 2018 topic), Evaluation of Ongoing Groundwater Efforts (February 2019 topic), etc.

### How do I sign up for an issue group?

- To sign up for an issue group, simply email ORSSAB Staff at [orssab@orem.doe.gov](mailto:orssab@orem.doe.gov) to express your interest and you will be added to the email list for that discussion. This may happen at any time, not just at the beginning of the fiscal year.

### How many issue groups may I sign up for?

- You may sign up for as many issue groups as you would like. You may also remove yourself from groups.

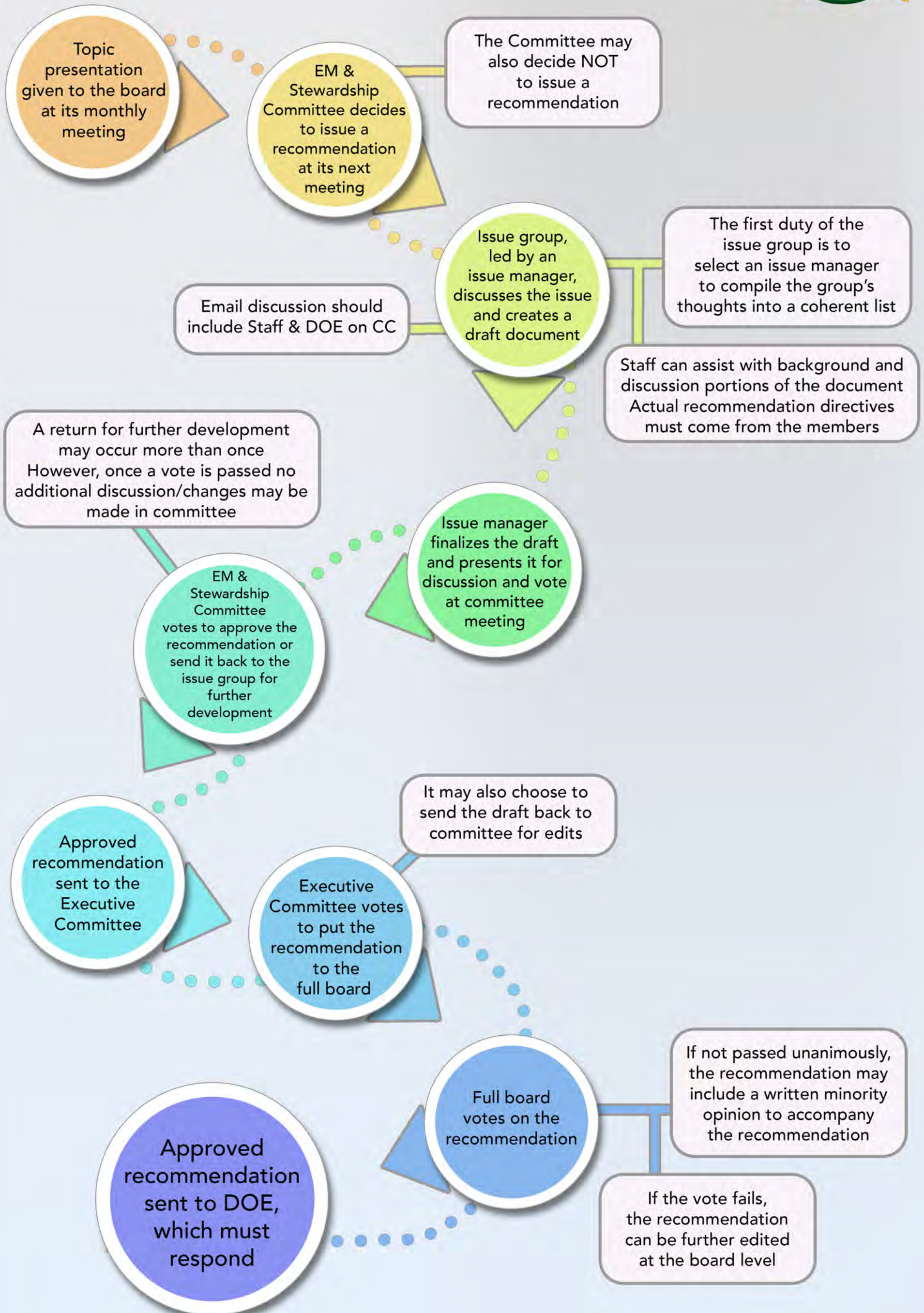
### I've signed up for an issue group – Why have I not heard anything further?

- Issue groups are primarily called to action when a board topic may require a recommendation to DOE, and often the board may decide a recommendation is not needed for a topic.





# THE RECOMMENDATION PROCESS





## The Recommendation Process & You

1. **Topic presentation given to the board at its monthly meeting as assigned from the work plan.**
  - a. The board meeting is where you will receive the most comprehensive overview of the topic from an expert on the issue. The expert outlines the challenges they are trying to solve, the remediation actions being taken currently and how those are progressing, and any future plans, etc. The most recent recommendation will be provided, if applicable, to help orient you to previous discussion on the topic. Ask questions!
  - b. For some topics, a tour may also provide an opportunity to become more educated on the issue and ask additional questions. It's a great idea to take your notes with you on the tour to review and ask additional questions as you think of them. Bring new insights to the upcoming committee discussion.
2. **The EM & Stewardship Committee meets for follow on discussion.**
  - a. The committee will decide whether or not to make a recommendation and begin crafting it
  - b. This is a working meeting. A subject matter expert will be on hand for detailed questions as members discuss potential recommendation items. Issue group members should gather ideas from the committee's discussion.
3. **The Issue group, led by an issue manager, further discusses the issue and compiles ideas into a draft document.**
  - a. The first duty of the issue group is to select an issue manager to facilitate the discussion and compile the group's thoughts into a coherent list.
  - b. Communication by the issue group can be in person or via email; staff can assist with meeting space on site, or members may go elsewhere.
  - c. Staff can assist with background and discussion portions of the document. Actual recommendation directives must come from the members.
4. **The Issue manager finalizes the draft and presents it for discussion and vote at a future EM & Stewardship Committee meeting**
  - a. Complex issues may take more than one meeting to resolve, but timeliness is also important.

## The Recommendation Process & You

5. **The EM & Stewardship Committee votes on the recommendation.**
  - a. It may approve the recommendation or send it back to the issue group for further development
  - b. Returns for edits may happen more than once, but once a vote is passed there may be no further discussion or changes.
6. **The approved recommendation sent to the Executive Committee.**
  - a. The Executive Committee may make minor edits.
  - b. It will voted to put the recommendation to the full board or it may choose to send the draft back to committee for additional work
7. **The board discusses the recommendation.**
  - a. If not passed unanimously, the recommendation may include a written minority opinion to accompany the recommendation.
  - b. The board may make additional edits or return the recommendation to the committee level.
8. **The approved recommendation is sent to DOE, which must respond to the recommendation in writing.**

## The Recommendation Process & You

### Desired Qualities in Site Specific Advisory Board Recommendations

Recommendations should be focused exclusively on the EM mission, and primarily on the EM mission in Oak Ridge. If questions exist on the appropriateness of a given subject, please consult with DOE staff.

Ideally recommendations will focus on goals and outcomes, rather than the details of how to reach an outcome. For example, it is helpful to hear from the Board on whether or not they support onsite disposal of any cleanup waste, and thoughts on alternative sites, but less helpful to provide recommendations on the technical details of how to construct a facility. Put differently, try to stay focused on the “big picture” and avoid moving into project management and engineering.

DOE is particularly interested in the Board’s views on the Oak Ridge area’s perspective on EM activities. Remember that this is intentionally established as a citizen’s advisory panel and not a panel of technical experts (though we do have members with strong expertise in relevant areas).

New ideas and cordial critiques are welcome. Don’t hold back, just keep those focus on positive contribution.

### EXAMPLE Recommendation Template

**Title:** Oak Ridge Site Specific Advisory Board Recommendation ### On The Example Topic

**Background:** *Staff will assist and members may edit.* A few paragraphs giving an overview of the issue and some history, including perhaps previous actions by DOE and partner agencies. Graphics or diagrams that help illustrate the issue.

**Discussion:** *Staff will assist and members may edit.* Brief overview of the history of actions/recommendations by the board on the issue, including the most recent meeting(s).

**Recommendation(s):** Brief summary of the board’s broad feelings on the topic and direction requested to be taken by DOE. Includes a list of particular items or subjects to be addressed and/or actions ranked by importance.
