Dear Ms. Sweeney:

Sabine Pass Liquefaction, LLC ("Sabine Pass") hereby submits¹ for filing under seal, a non-redacted copy of the Novation and Amendment Agreement, dated February 17, 2022, among Cheniere Marketing, LLC ("Cheniere Marketing"), Sabine Pass and Glencore Ltd. ("Glencore"), among others (the "Novation and Amendment Agreement") and the amended and restated long-term sale and purchase agreement (the "A&R SPA") entered into by Sabine Pass on February 17, 2022 with Glencore for the long-term sale and export of liquefied natural gas ("LNG") from the Sabine Pass LNG Terminal. The Novation and Amendment Agreement assigns to Sabine Pass the previously submitted long-term sale and purchase agreement entered into by Cheniere Marketing and Glencore on October 22, 2021 and provides for the execution of the A&R SPA to amend and restate the original long-term sale and purchase agreement in connection with such assignment.

Sabine Pass is also filing herewith a public summary of the major provisions of the A&R SPA. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy ("DOE/FE") Order Nos. 2833, 2961-A, 3306, 3307, 3384, 3595, 3669, 3792, and 4520 (each as may have been amended).² Sabine Pass hereby requests confidential treatment of the

**Amended and Restated LNG Sale and Purchase Agreement
Major Provisions Summary**

**AMENDED AND RESTATED LNG SALE AND PURCHASE AGREEMENT (FOB),
DATED FEBRUARY 17, 2022, BETWEEN SABINE PASS LIQUEFACTION, LLC AND
GLENCORE LTD.**

1. DOE Order/FE Docket No(s):

2. LNG Liquefaction/Export Facility and Location:

LNG may be delivered by Seller to Buyer at the Sabine Pass LNG Terminal located in Cameron Parish, Louisiana or at any number of liquefaction plants, subject to the terms and conditions of the contract.

3. Describe affiliation with LNG Liquefaction Export Facility (e.g., owner, capacity holder, etc):

The contract was initially entered into by Cheniere Marketing, LLC. Cheniere Marketing, LLC has assigned the contract to Sabine Pass Liquefaction, LLC, the owner of the Sabine Pass LNG Terminal.

4. Exact Legal Name of Parties/Counterparties to Contract:

Seller: Sabine Pass Liquefaction, LLC
Buyer: Glencore Ltd.

5. a. Contract Type (e.g. Purchase and Sale Agreement; Liquefaction Tolling Agreement, etc.):

Novation and Amendment Agreement

b. Firm or Interruptible Contract:

6. Date of the Contract:

February 17, 2022

7. Contract Term:

Pursuant to the terms of the contract, a supply period of approximately thirteen (13) years, beginning in 2023.

8. Annual Quantity:

An amount equal to approximately forty-two million (42,000,000) MMBtus per full calendar year, subject to the terms and conditions of the contract.

9. Take or Pay (or equivalent) Provisions/Conditions:

Pursuant to the terms of the contract, during any contract year, the Seller is obliged to make available to Buyer the scheduled cargo quantity, or compensate Buyer if not made available, unless otherwise excused under the contract. Similarly, during any contract year, the Buyer is obliged to take and pay for the scheduled cargo quantity, or compensate the Seller if not taken, unless otherwise excused under the contract.

10. Supplier (title holder) of Natural Gas to Liquefaction Facility (include whether long or short-term supply, or both), if appropriate:

11. Legal Name of Entity(ies) that has(have) Title to the Natural Gas and LNG through the LNG Facility until Export (at the Flange of the Vessel):

Sabine Pass Liquefaction, LLC or other entity (as applicable, depending upon delivery point)

12. Export Destination Restrictions in the Contract:

The contract restricts resale or transfer of LNG received by the Buyer under the contract to destination countries permitted under (i) the applicable DOE/FE export authorizations and (ii) U.S. law.

13. Resale Provisions:

The contract provides for the parties to agree to comply with the applicable export authorizations, including incorporating into any resale contract for LNG sold under the contract the necessary conditions to ensure compliance with the applicable export authorizations.

14. Other Major Non-proprietary Provisions, if applicable:

None
