ORDER GRANTING REQUEST TO VACATE LONG-TERM
AUTHORIZATION TO IMPORT NATURAL GAS FROM CANADA

DOE/FECM ORDER NO. 3412-A

APRIL 22, 2022

On March 18, 2014, the Office of Fossil Energy and Carbon Management (FECM) (formerly the Office of Fossil Energy)¹ of the Department of Energy (DOE) issued Order No. 3412² to Jordan Cove LNG L.P. (JCLNG or Jordan Cove LNG) under section 3(c) of the Natural Gas Act (NGA).³ Under this order, JCLNG is authorized to import natural gas from Canada by pipeline in a volume up to 565.75 billion cubic feet per year (Bcf/yr) to the proposed Jordan Cove LNG Terminal (Terminal), to be located within the Port of Coos Bay, Oregon. The natural gas may be imported for a term of 25 years, beginning on the earlier of the date of first import or 10 years from the date the authorization was issued (March 18, 2024).

On March 25, 2022, JCLNG submitted a request asking DOE to vacate Order No. 3412 (Request).⁴ In support of this Request, JCLNG states that its affiliate, Jordan Cove Energy Project L.P., “will not be moving forward” with the proposed Terminal.⁵

Accordingly, pursuant to NGA section 3(c), JCLNG’s authorization granted in Order No. 3412 is vacated, effective immediately.
