Proposed Action Title: Stanford University -- Additive Manufacturing of Amorphous Metal Soft Magnetic Composites

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Palo Alto, California; Baltimore, Maryland

Proposed Action Description:

Funding will support the project team's small-scale research and development to additively manufacture amorphous metal-oxide soft metal composites (SMC), key to increased energy density and efficiency of electric motors for electric and hybrid vehicles, with reduced cost and material waste. Specifically, the project team will 1) apply laser powder bed fusion to solution-processed oxide-coated amorphous metal particles to fabricate rods and toroids for the evaluation of magnetic and mechanical properties, 2) use printed SMC rods to construct inductors, and 3) test inductor performance within a calorimetric chamber for precise measurement of losses. If successful, this project will develop and validate magnetic cores with 10x lower core loss at frequencies of 500 kHz to 1 MHz at half the price of conventional manufacturing.

Project activities will be conducted at existing facilities at Stanford University (Palo Alto, CA) and Johns Hopkins (Baltimore, MD) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.
