Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

#### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Portland General Electric (PGE) to design, develop, retrofit, and operate energy efficient technologies in select buildings in Portland, OR.

All project planning, modeling, testing, community outreach, and installation would be carried out by PGE, the Energy Trust of Oregon, and the Community Energy Project in Portland, OR. The National Renewable Energy Laboratory (NREL) in Golden, CO would also help develop software and assist in analyses.

This award would be carried out in five budget periods (BPs). This NEPA Determination (ND) includes all of Budget Period (BP) 1, as well as Task 6 and Subtask 7.1 in BP2. The remaining tasks in BP2 and all tasks in BP3, BP4, and BP5 are dependent on customer engagement and data gathered in BP1, Task 6, and Subtask 7.1. As such, the potential impacts of these remaining activities cannot be reviewed at this time, and additional NEPA review would be required in the future.

The proposed project activities in BP1 would consist of intellectual, academic, and analytical activities only, such as design, data analysis, cyber security planning, grid modeling, community engagement, and software development. BP2 Task 6 and 7.1 would involve launching the campaign and customer engagement. The project plans incorporating community and customer involvement would be submitted to the cognizant Institutional Review Board (IRB) to determine if any of the proposed activities are considered human subjects research and, if so, IRB approval in accordance with 10 CFR 745.103 would be obtained prior to initiating the proposed activities in the field.

All activities will be conducted in existing purpose-built office or laboratory settings. No installation, construction, or ground disturbing activities would occur in BP1, Task 6, or Subtask 7.1.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

#### FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

A portion of the proposed action is categorically excluded from further NEPA review. The NEPA Provision identifies Topic Areas, Budget Periods, tasks, and/or subtasks that are subject to additional NEPA review.
