

State, local and tribal grantees submit their quarterly reports and DOE officials are able to approve the Quarterly Program Report that track the spending of funds and progress of programmatic impacts. This process of check and balance occurs until the grant fund cycle is complete and the grant is closed and ultimately retired.

Individuals cannot be located outside of their work place. The system has no capability to monitor individuals.

Retention & Disposition		
22. What are the retention periods of data in the information system?	The retention requirement for programmatic data is for the life of the EECBG – as long as the EECBG programs continue, the information will be required for historical performance reporting. The retention requirement for grant data is estimated to be 10 years. The exact length of time for retaining the information is determined by the procurement office that manages the information.

23. What are the procedures for disposition of the data at the end of the retention period?

The procedures around the disposition of data are documented in the Hard Disk Sanitization Procedures. The EERE Support Team uses BCWipe for sanitization of hard disks on systems that will either be transferred or retired. However, data is retained on backup tapes indefinitely.
