The purpose of Contract Modification P00084 is to administratively correct internal line item data for CLIN 0002 and CLIN 0008. The internal Total Values for CLIN 0002 and 0004 were erroneously manually adjusted beginning with Modification P00031 and cascading forward with each subsequent incremental funding Modification through P00078. As a result of this modification, the internal Total Value for CLIN 0002 has been manually corrected from \$16,403,893,413.03 to \$10,764,625,324.97 and the internal Total Value for CLIN 0008 has been manually corrected from \$1,286,515,367.61 to \$917,731,038.61. As a result of these two corrections, the Total Value for the contract is internally corrected to \$24,340,357,646.58.
