Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the University of Virginia (UVA) (Charlottesville, VA) to demonstrate how silver can be recycled from old silicon solar cells and reused in new solar cells.

Proposed project activities would include laboratory scale activities at UVA. All proposed work would be completed in existing, purpose-built facilities and no ground disturbance would occur as a result of project activities. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

The handling of hazardous substances such as nitric acid would be managed in accordance with federal, state, and local environmental regulations. Existing corporate health and safety policies and procedures would be followed, including the proper training of employees and the usage of safety goggles.

Proposed project activities would include the use of nanoparticles. Silver nanoparticles would be dispersed in a liquid and stored in a bottle in order to mitigate the risk of inhalation.

## FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
