Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

## Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

#### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the University of Connecticut (UC) (Storrs, CT) for the design, development and testing of a light intensity modulation impedance spectroscopy (LIMIS) system, which would be used to interpret the absorption, emission, and intensity of light that affects and reaches photovoltaic (PV) panels. The LIMIS system would be used to investigate and characterize small-scale PV panels before and after thermal and mechanical degradation.

Proposed project activities would include laboratory scale research, comprised of building a LIMIS testbed, validating the LIMIS system and degradation methods, and identifying responses of small PV panels to thermal and mechanical impacts. Proposed project activities also include recruiting undergraduate students from groups underrepresented in science, technology, engineering, and mathematics (STEM).

This project would include the handling of potentially hazardous materials. All materials would be handled in the lab, which follows strict university environmental safety and health policies for handling chemical waste, including proper disposal in accordance with federal, state, and local regulations.

There are no physical modifications to existing facilities, construction of new facilities, no ground disturbing activities, no changes in use of existing facilities, and no installation or deployment of outdoor equipment. There are no new permits or licenses required.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
