## Alaska LNG Project LLC, Docket No. 14-96-LNG

Cook Inletkeeper and the Center for Biological Diversity (collectively, the Movants) sent a Motion to Intervene (Motion) in the above-captioned proceeding to the Department of Energy's (DOE) Office of Fossil Energy and Carbon Management (FECM) via the United States Postal Service (USPS) priority mail.

For reasons beyond the Movants' control, FECM did not receive the Motion through DOE's normal mail processes, nor did FECM learn of the Motion until Alaska Gasline Development Corporation (an intervenor in the proceeding) submitted an Answer in Opposition to the Motion on August 30, 2022.

Upon further inquiry, FECM learned that the Movants postmarked the Motion at 4:25 p.m. local time in Juneau, Alaska, on August 15, 2022. The USPS delivered the Motion to DOE at 10:53 a.m. local time on August 19, 2022.

In light of the circumstances, DOE asked the Movants to resubmit the Motion electronically to the email address FERGAS@hq.doe.gov, which they did on September 26, 2022. FECM is now posting the Motion in the docket with the date stamp of August 19, 2022 (the date the Motion was physically delivered to DOE), together with the supporting correspondence between FECM and the Movants.
