The applicant shall provide immediate written notice to DOE if at any time the applicant learns its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.

Additional certifications and assurances may be required of the applicant as a condition on the receipt CIFIA Loan under the CIFIA program.
