In accordance with the conditions of Department of Energy, Office of Fossil Energy and Carbon Management ("DOE/FECM") Order No. 4839<sup>1</sup> issued July 12, 2022, New Fortress Energy Louisiana FLNG LLC ("NFE Louisiana") hereby submits for filing in the above-referenced docket this semi-annual report as required by ordering Paragraph H, describing the progress of the proposed New Fortress Energy Louisiana FLNG Project ("Project").

On March 31, 2022, NFE Louisiana filed an application for a license to construct, own, and operate the Project pursuant to the Deepwater Port Act of 1974, and in accordance with the United States Coast Guard ("USCG") and the Maritime Administration's ("MARAD") implementing regulations. NFE Louisiana is currently engaged with MARAD and USCG staff to progress its application and is pursuing all other outstanding state and federal authorizations. Based on current schedule, the Project is expected to commence commercial operations by second quarter 2023.

NFE Louisiana has not yet executed long-term supply and export contracts associated with the long-term export of LNG from the Project, but will file any executed agreements when available.
