Pursuant to the above-referenced Orders, Sabine Pass Liquefaction, LLC ("Sabine Pass"), herein submits its semi-annual report for March 1, 2022, through August 31, 2022. This report includes a list of the items which have been filed during the reporting period relating to long-term contracts associated with the long-term export of LNG from the Sabine Pass Terminal, as well as long-term gas supply contracts.

- Sabine Pass submitted the following new long-term contract(s) associated with the long-term export of LNG from the Sabine Pass Terminal during the reporting period:
 - On May 25, 2022, Cheniere Marketing, LLC ("CMLLC") entered into an agreement with Posco International Corporation for the long-term sale and export of liquefied natural gas from the Sabine Pass Terminal.
 - On June 8, 2022, CMLLC entered into an agreement with Equinor ASA for the long-term sale and export of liquefied natural gas from the Sabine Pass Terminal.
 - On June 21, 2022, Sabine Pass entered into an agreement with Chevron U.S.A. Inc. for the long-term sale and export of liquefied natural gas from the Sabine Pass Terminal.
 - o On June 21, 2022, CMLLC entered into an agreement with Chevron U.S.A. Inc. for the long-term sale and export of liquefied natural gas from the Sabine Pass Terminal.
 - On July 15, 2022, CMLLC entered into an agreement with PetroChina International Company Limited for the long-term sale and export of liquefied natural gas from the Sabine Pass Terminal.
- Sabine Pass submitted the following item(s) related to previously entered long-term contracts associated with the long-term export of LNG:
 - On June 15, 2022, Cheniere Marketing International LLP ("CMI"), Corpus Christi Liquefaction, LLC ("CCL"), and CPC Corporation, Taiwan ("CPC") entered into a Novation and Amendment Agreement, which amends and assigns to CCL the previously submitted LNG sale and purchase

- agreement entered into by CMI and CPC on August 11, 2018.
- On June 15, 2022, CMLLC, CCL, and Sinochem Group Co., Ltd. ("Sinochem") entered into a Novation and Amendment Deed, which amends and assigns to CCL the previously submitted LNG sale and purchase agreement entered into by CMLLC and Sinochem on November 4, 2021.
- On June 15, 2022, CMI and Polskie Gornictwo Naftowe i Gazownictwo S.A. ("PGNiG") entered into an Amended and Restated LNG Sale and Purchase Agreement, which amends and restates the previously submitted LNG sale and purchase agreement entered into by CMI and PGNiG on November 8, 2018.
- Sabine Pass submitted the following new long-term gas supply contract(s) during the reporting period:
 - On April 6, 2022, and April 7, 2022, Sabine Pass entered into two Transaction Confirmations with Shell Energy North America (US) L.P., both governed by that certain NAESB Base Contract for Sale and Purchase of Natural Gas dated May 1, 2015, for an aggregated annual contract quantity approximating 36,000,000 MMBtu.
