Proposed Action Title: Graphite Pellet Pressing for Vapor Digestion Studies

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Graphite will be mixed with simulants of fission products and heavy metals. The powder mixture then be pressed into pellets ranging from 1/2 inch to 1.5 inches in diameter. These pellets are to be used in vapor digestion testing covered under another activity's EEC.
