

Proposed Action Title: Physically Isolate FGDS Propane Supply From 773-A and 735-A

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Propane supplied from the Flammable Gas Distribution System (FGDS) is no longer required throughout the facility and is only required for operations in room D-0101 (Glass Shop).

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
