Proposed Action Title: Potential Routes for Titanium and Mercury Concentrations within SWPF Flowsheet

Proposed Action Description:

The study will involve the determination of the radiation stability of monosodium titanate (MST) in (1) simple simulant salt solution, (2) C0-60 radiation stability of MST in simulant solution, (3) MST stability while in contact with routine Tank 49 supernatant and (4) MST stability while in contact with alpha and gamma generating source in the presence of simulant salt solution.
