In accordance with DOE/FE Order No. 3147 (as amended) in FE Docket No. 12-88-LNG and Order No. 3978 (as amended) in FE Docket 12-156-LNG, Golden Pass LNG Terminal LLC ("GPLNG") hereby submits for filing to the Department of Energy, Office of Fossil Energy and Carbon Management a summary of major provisions (Attachment A) from an executed long-term natural gas sale and purchase agreement ("SPA"), (Attachment B) between GPLNG and NextEra Energy Marketing ("NEM").

Pursuant to 10 CFR §1004.11(f), GPLNG requests the confidential treatment of the underlying contract (Attachment B), including both the base NAESB and the transaction confirmation, as it contains commercially sensitive financial information that is maintained in confidence by the parties to the contract, is not available to the public, is the type of information customarily held in confidence, and the disclosure of which is likely to cause harm to the competitive positions of the parties.

Summary of Major Provisions

2. LNG Liquefaction and Export Facilities Location:

Golden Pass LNG Terminal located on the Sabine-Neches Waterway, approximately 10 miles south of Port Arthur, Texas.
