## **A. PROPOSED ACTION DESCRIPTION:**

Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), conducted an emergency replacement of structure 34/7 on its existing Pilot Butte-Copper Mountain (PB-COP) 34.5-kV Distribution Line, in Fremont County, Wyoming, in December 2022. To access this structure, a skid-steer loader was used to clear drifted snow within WAPA's existing distribution line and access road rights-of-way (ROWs) between PB-COP Structures 31/7 and 38/2. The structure replacement included removing the existing structure, re-auguring the existing structure hole, installing the new wood structure, backfilling the structure holes, and installing new hardware. Equipment used for this project included bucket trucks, a skid-steer loader, and utility trucks. Work was confined to WAPA's existing ROWs on private lands and tribal lands managed as the Wind River Reservation.
