Project Title: Sediment and Groundwater Sampling at the Legacy Management Field Support Center at Grand Junction, Colorado

Location: Legacy Management Field Support Center, Grand Junction, Colorado

Proposed Action or Project Description:

LM is proposing to conduct sediment and groundwater sampling at the Legacy Management Field Support Center (LMFSC) in Grand Junction, Colorado located in Mesa County. Proposed activities would include the collection of water and sediment samples by hand at the north end of the site in the vicinity of the north and south ponds, monitoring wells, and near the Gunnison River. The proposed actions would be necessary to meet LM's Goal 1, the protection of human health and the environment, and Goal 6, engaging the public, governments, and interested parties. The use of mechanized ground-disturbing equipment and tools (e.g., powered digging tools) would be excluded from this scope of work.
