

## Weatherization Assistant Version 10

Example Conversion Timeline

**Weatherization Assistant web-based (WAweb)** – Web-based suite of audit tools (including Version 10 of the National Energy Audit Tool (NEAT) and Manufactured Housing Audit (MHEA)) managed by Oak Ridge National Laboratory (ORNL) for the U.S. Department of Energy (DOE) in support of the Weatherization Assistance Program (WAP).

Applicability –DOE Weatherization Assistance Program Grantees with Weatherization Assistant Version 8 audit approval extending *at least 6 months beyond* the start of the Program Year shown. Grantees whose audit approval does not extend as noted should follow the audit approval processes contained in <u>Weatherization Program Notice 23-6: Revised Energy Audit Approval</u> <u>Procedures, Related Audit and Material Approvals Including Fuel-Switching and Solar PV</u>.
