

Proposed Action Title: Replacement of 233-H Kanne Rotameters

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC addresses the MT to design and install new rotameters to replace the obsolete rotameters in the 233-H Tritium Air Monitoring system. Parts removed may be used as spare parts until the completion of the MT. MT-TRI-2022-00016 - Replace of 233-H Kanne Rotameters is attached as reference and provides requirements for the replacement rotameter.
