Proposed Action Title: Cold Feed Chemicals Caustic Transfer Pump (S422-010-031-00-P) Replacement

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Replace the existing Cold Feed Chemical Systems Caustic Transfer Pump (422-010-031-00-P), system NAK with a state-of-the-art transfer pump since the existing Buffalo Forge pumps are no longer manufactured and the replacement of the pump motors is impractical due to their high cost and the long lead time for procuring them.

The Caustic Transfer Pump transfers 50% caustic from the Caustic Storage Tank, located in the 422-S Cold Feeds Facility, to either of three locations: 1) Caustic Feed Tank in 221-S on 3rd Level, West Corridor, 2) Decon Solution Makeup Tank in 422-S, and 3) Caustic / Organic Acid Waste Neutralization Tanks and 5% NAOH Mix Tank in the 980-S Facility.

These replacement transfer pumps will have no impact on the emission rates of the tanks the pumps feed since the feed rates will be similar to those feed rates used to determine maximum potential emissions.
