Proposed Action Title: Perform Test of Electrical Resistance Tomography (ERT) System at the Low Level Radioactive Waste Disposal Facility Trench Area 2 Cap

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

An electrical resistance tomography (ERT) system (a geophysical method) will be tested on the low permeability geosynthetic cap over the closed Trench Area 2 at the Low Level Radioactive Waste Disposal Facility (LLRWDF) in E Area. The ERT system will measure electrical properties of the subsurface materials.
