

Proposed Action Title: Wetland Restoration and Gopher Frog Conservation - SREL

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The researcher will release headstarted gopher frogs at three sites and compare survival under different release and vegetative restoration methods. Research will be conducted at various Carolina Bays (see attached site use maps). This work is part of a statewide initiative to increase gopher frog populations and potentially help the species avoid federal listing in 2025.
