Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Triton Systems, Inc. (Triton) to design, fabricate, and test a full-scale anchoring system which would have applications in the offshore wind energy industry. Testing activities would include an offshore field test.

The proposed activities for this award are separated into fourteen tasks. This NEPA Determination (ND) only applies to Tasks 1 – 4. Such activities must be completed to obtain sufficient information which is necessary to conduct a meaningful review of the remaining activities, i.e., Tasks 5 – 14. Activities under Tasks 1 – 4 would include those of an analytical, intellectual, and academic nature, including: literature reviews, data analysis, document preparation, project management, and design activities which would not be dependent on findings from later activities (e.g., geotechnical investigations) which this ND does not apply to. These activities would be completed by Triton and the University of New Hampshire (UNH).

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
