

Proposed Action Title: Hanford Vacuum Evaporation, Oxidation, Hydrolysis, and Solubility of Organics for Sample-and-Send

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Non-radioactive laboratory testing using simulants to study evaporative separation and solution oxidation, hydrolysis, and solubility of trace regulated organic chemicals using a 4 to 8 molar sodium alkaline simulant. The trace chemical spikes are from some of the organic chemicals shown in 40 CFR 268.48.
