Categorical Exclusion Determination Form

Proposed Action Title: Install Temporary Portable Diesel Generator in TEF

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The Tritium Finishing Facility (TFF) requires the power feeds to 233-H be re-routed and tapped into the 6A/6B feeders. These feeders also supply the Tritium Extraction Facility (TEF). As a result, TEF must incur an outage of approximately 10 days (14 day max), during which the permanently installed Diesel Generator (DG) will act as the primary power supply for TEF. This portable diesel generator will serve as a backup to the permanently installed diesel generator.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
