Proposed Action Description:

This activity details the general operation of the FormLabs SLA resin 3D printers (Form2 and Form3 variations) along with the post-processing tasks associated with 3D printed components. The FormLabs Form2 and Form3 printers are stereolithography apparatus (SLA) that utilizes focused light sources to cure photo-curable resin into hardened 3D components.

Rev. 1: Activities listed to include the addition of the ProFluidics 285D microfluidic printer system and its associated 3D microfluidic printed components.
