Proposed Action Description:

H-Canyon's processing of Fast Critical Assembly (FCA) fuel will require the SRNL's Nuclear & Chemical Processing (N&CP) organization's analytical support for the analysis of dissolver chemical make-up samples and samples containing dissolved FCA fuel for waste characterization and Nuclear Material Control and Accountability (MC&A) purposes.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
