SUBJECT: DEPARTMENT OF ENERGY AMERICAN INDIAN TRIBAL GOVERNMENT INTERACTIONS AND POLICY

- PURPOSE. This Order communicates Departmental, programmatic, and field responsibilities for interacting with American Indian Governments and transmits the Department of Energy's (DOE) American Indian and Alaska Native Tribal Government Policy (hereafter "Indian Policy") including its guiding principles, and transmits the Framework for Implementation of the Policy.
- 2. <u>CANCELLATION</u>. DOE O 1230.2, American Indian Tribal Government Policy, dated 4-8-92. Cancellation of a directive does not, by itself, modify or otherwise affect any contractual obligation to comply with the Order. Contractor Requirement Documents (CRDs) that have been incorporated into or attached to a contract remain in effect until the contract is modified to either eliminate requirements that are no longer applicable or substitute a new set of requirements.
- APPLICABILITY.
 - DOE Elements. Except for the exclusions in paragraph 3c, this Order applies to

DOE American Indian & Alaska Native Tribal Government Policy

- Principles for DOE to follow to ensure effective government-togovernment relationships with American Indian and Alaska Native Tribal governments.
- Published in 1992 and updated in 2009.

DOE Order 144.1 DOE American Indian Tribal Government Interactions

- Lays out responsibilities for DOE staff and contractors to meet the agency's obligations for interacting with Tribal governments.
- The 2009 order focused on DOE communication with Tribes at sites and facilities and on transportation issues.



Need for Policy/Order Update

President Biden's January 2021 Memorandum on Tribal Consultation and Strengthening Nation-to-Nation Relationships

- Instructed federal agencies to consult with Tribes and develop an action plan to implement the policies and directives of Executive Order 13175

DOE Directives Process

DOE Secretary or Deputy Secretary make decisions on policy/order/directives based on DOE Directives Review Board (Board).

- The Integrated Project Team (IPT) includes representatives from each program office who are experienced in working with Tribes. They will share recommendations with the Board.
 - The draft policy and order show recommendations from the IPT.
- Most DOE directives have no input from entities outside the agency because they are DOE's internal policies. In this case, we seek Tribal leader input on the policy and order before sending recommendations to the Board.

Input Considered So Far

Includes input from:

- Comments and letters from Tribal leaders during April 2021 consultation on DOE consultation practices
- The 2021 Presidential Memorandum on Tribal Consultation and Strengthening Nation-to-Nation Relationships
- The MOU Regarding Interagency Coordination and Collaboration for the Protection of Tribal Treaty Rights and Reserved Rights
 - These MOUs were developed after Tribal consultation
- The MOU Regarding Interagency Coordination and Collaboration for the Protection of Indigenous Sacred Sites
- Important concepts like incorporating Indigenous Knowledge, protecting sacred sites, and acknowledges the importance of Indigenous Languages.

The proposed revisions also underwent legal review.



Key Changes in the Draft Order and Policy

DOE intends that these revisions clarify roles, responsibilities, and requirements, and strengthens DOE's support of Tribal consultations and interactions and capacity to better meet the agency's Tribal trust obligations.

- Expands the requirements for Tribal **training** for DOE officials to understand the Department's responsibilities to Tribal nations.
- Gives more guidance on what DOE needs to do to support Government-to-Government consultation and engagement with Tribes and ANSCA Corporations.
- Provides additional details on what needs to be included in annual reporting from DOE offices to DOE headquarters.
- Designates in writing one or more **Tribal Liaison Officer positions** in each program office and at least one Tribal liaison for each field office or site.
- Requires program offices to develop an implementation plan to implement this
 Order and Policy, including identifying staff, budget, and training.
