Proposed Action Title: Install New 773-A CHEX HEPA Filter Fluid Seal Housings

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The modification installs a total of forty (40) newly purchased HEPA filter fluid seal housings in place of existing tape-in-place filter housings in the 773-A B and C Central Hood Exhaust (CHEX) system. Revision 1 of the EEC adds twenty (20) additional housings in B/C CHEX system. Revision 2 of the EEC adds the capability to replace all of the tape-in-place housings with HEPA filter fluid seal housings for CHEX and PHEX filter banks.
