Proposed Action Title: Preparation and Analysis of Solid Formation from Simulated Long-Term Dissolved Used Nuclear Fuel

Program or Field Office: Savannah River Site

Proposed Action Description:

SRNL and the University of Florida will experiment with non-irradiated Al-clad uranium fuel surrogates and uranium silicide fuel to determine the characteristics for solid formation during nuclear fuel dissolution. Nonradioactive scoping experiments will ascertain worthwhile experiments to repeat with radioactive material. Radioactive isotopes will then be used. Any waste generated at the University of Florida will be disposed of by UF in accordance with their policies and procedures.
