Dear Mr. Feinberg:

The Department has reviewed the above-referenced documents and, per the conclusions in the 1/13/12 Assessment Report, has made a determination to incorporate the proposed Solid Waste Management Units ("SWMUs") described therein into Module II, Condition A.3 of DOE-Environmental Management's ("DOE-EM") 6 NYCRR Part 373 Permit, # 4-4224-00024/00042, effective date 9/29/08. Please note that the new SWMUs have also been added to Module II, Condition A.3.(d) of the renewed DOE-Naval Reactors Laboratory Field Office 6 NYCRR Part 373 Permit, # 4-4224-00024/00001, effective date July 30, 2012. The SWMUs are incorporated into both permits in accordance with the following.


The Department has designated "Frac Tanks 1" and "Frac Tanks 2" as "SPRU Fractionation Tanks 1" (SWMU-081) and "SPRU Fractionation Tanks 2" (SWMU-082), respectively. Based on information provided within the 1/13/12 Assessment Report, and the previously submitted release notification and assessment of 11/18/10, these SWMUs are dispositioned as follows:

- SWMU-081 has been designated as "no further action" at this time, in accordance with the provisions of Module II, Condition E.1.(a) of DOE-EM's fore-mentioned Part 373 Permit;
- SWMU-082, as pertains to Frac Tank THDS-1, will be addressed via the 11/30/11 Upper Level Interim Corrective Measures Work Plan (with revisions as necessary), in accordance with the provisions of Module II, Condition E.8.(a) of DOE-EM's Part 373 Permit, and as previously discussed with DOE-EM, SPRU Field Office.

Please note that any subsequent releases discovered at either of these SWMUs will be subject to the notification provisions of Module II, Condition D of your Part 373 Permit.
