Proposed Action Title: Perform Sampling and Excavation of Soil Containing Cesium-137 Slightly Above Background Levels Adjacent to H-Area Seepage Basin 904-44G

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Operations and Maintenance Plan 24-001 describes the excavation of a known soil "hot spot" slightly above background levels containing cesium-137 located off the northeast corner of the closed H-Area Seepage Basin 904-44G. The excavation will be within the SRS Index 225 *Spill on 02/01/57 of Unknown Seepage Basin Pipe Leak from 904-44G*. This work is being performed for purposes of ground maintenance and maintain/improve parking area to service the nearby wells. The maximum anticipated impacted surface area will be an approximate 480 square feet (20ft x 24ft).
