

Proposed Action Title: Repair Roof Drain Leak At 105-C Personnel Wing

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Repair roof drain leak in elbow above conference room ceiling. Elbow and leak location (determined by Subcontractor) is covered by insulation with asbestos mastic. Leak causes conference room, adjoining office and corridor to flood. Removal and dispose of existing furniture and carpet at both locations. Deteriorating conditions can cause worker issues due to mold and mildew.

Construction to remove insulation and repair leak.
