Proposed Action Description:

This EEC covers all excavation work activities at SRS when it has been determined that a CERCLA O&M Plan is required. These excavation activities may include corrective and/or preventative maintenance on underground Systems, Commodities, or Utilities (SCUs), installation and/or removal of sign posts, fence posts, steam poles, and/or electrical poles.
