This modification removes the COVID-19 3610 - Paid Leave under Section 3610 and the 52.223-99 COVID related clauses that supported Executive Order 14042, Ensuring Adequate COVID Safety Protocols for Federal Contractors. On May 9, 2023, President Biden signed an Executive Order revoking Executive Order 14042, which had required certain parties contracting with the Federal Government to follow certain COVID-19 safety protocols. Effective May 12, 2023, all prior guidance from the Safer Federal Workforce Task Force (Task Force) implementing the requirements of Executive Order 14042 had been revoked. Continued ...
