

A. Obligate funds to CLIN 0001, (DOE Funds) in accordance with SRNS FINPLAN No. 124 for FY 2023. Funds in the amount of \$27,606,077.58 are hereby obligated to CLIN 0001, thereby increasing it from \$18,820,809,324.00 to \$18,848,415,401.58.
