## Are You Ready to Help Improve Geothermal Wellbore Tools and Technologies?



Let's find out with a quick guide to navigate the **Combined Wellbore Construction High Temperature Tools and Reservoir Thermal Energy Storage (RTES) Funding Opportunity Announcement (FOA)**!



This is a combined FOA with two Topic Areas. In **Topic Area 1**, the FOA is seeking solutions for **downhole cement and casing evaluation tools for use in high-temperature and hostile geothermal wellbores**. The objective is to reduce wellbore construction costs while creating long-term durability.

This guide provides tips for the key items you'll need—but be sure to read the FOA in its entirety, too! Note that if a section identified in the tips below does not specify a topic area, you can assume that the requirements in that section apply to **both** topic areas.

Determine if the **Topic Area 1** opportunity is a good fit for you. If you have ideas or innovations for wellbore tools and technologies to supplement and advance beyond those currently available for cement and casing evaluation, chances are the answer is yes!

- **Sections I.A.i.1, I.A.ii.1, and I.B.1** of the FOA provide details that can help you decide if your ideas, tools, and technologies are a fit for Topic Area 1.
- **Sections II.A.i, III.B.1, and III.B.i–vi** of the FOA provide information on the available funding and the cost share your company or organization would need to provide to participate.

Make sure you're eligible by reviewing the eligibility requirements in **Section III** of the FOA.

Collate your ideas and determine how you want to discuss potential solutions that will meet the FOA needs and objectives. Check out details on the technology space and goals in **Section I.A.ii.1** of the FOA to ensure that your ideas align with what is being funded.

4

Write your application! Read the **Eligibility Information** in Section III and consider the **Technical Review Criteria** in **Section V.A.i.1** and **Program Policy Factors** in **Section V.C.i** in developing your project plan and application materials. Note that the Program Policy Factors include several applicable to both FOA Topic Areas, plus one specific to **Topic Area 1 only**.

Edit and review your application to ensure you have covered everything that's needed and that you meet the requirements in the **Application and Submission Information** in **Section IV**.

## SUBMIT YOUR APPLICATION!



Submit your application in **EERE eXCHANGE** by **5:00 p.m. ET on April 1, 2024**, using the instructions in the **Application and Submission Information** in **Section IV**. Potential applicants will be required to have a **Login.gov** account to access **EERE eXCHANGE**. You can find more information in **Section VI.B.i, Registration Requirements** in the FOA.
