## UPDATED NOTICE OF ENVIRONMENTAL ASSESSMENT UNDER THE NATIONAL ENVIRONMENTAL POLICY ACT

FEBRUARY 16, 2024

On October 23, 2023, the Office of Fossil Energy and Carbon Management (FECM) of the Department of Energy (DOE) announced that, in connection with the non-free trade agreement (non-FTA) countries<sup>1</sup> portion of Mexico Pacific Limited LLC's (MPL) application under section 3 of the Natural Gas Act (NGA)<sup>2</sup> and in accordance with the National Environmental Policy Act (NEPA),<sup>3</sup> it would prepare an environmental assessment (EA) of MPL's proposed project.<sup>4</sup> DOE stated that the Environmental Assessment (EA) would rely, in part, on existing environmental analysis.<sup>5</sup>

On January 26, 2024, DOE announced that it is temporarily pausing review of applications to export LNG to non-FTA countries while it works to update the economic and environmental analyses that inform its determination of whether such applications are in the "public interest."<sup>6</sup>

Because DOE is updating the environmental analysis upon which it will rely for its environmental assessment of MPL's proposed project, the NEPA review process for the proposed project will not be completed until the relevant updates are complete.
