

Proposed Action Title: Remove Steam Valve HPS-06M and Cut/Cap Line

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

DCF to remove steam valve HPS-06M (H1-802000-EXPS-V-411) and cut & cap steam line with welded pipe cap.
