Proposed Action Title: Gas Mass Spectrometry

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The SRNL Analytical Development uses laboratory module 139 for development of sensors to detect and support hydrogen research. Opportunities to expand the research to other energy and possibly atmospheric applications will also be sought. Development of gas mass spectrometers for analyses of hydrogen and residual or trace gases including most atmospheric and inert gases as well as light hydrocarbons may be performed in this lab.

Rev. 3 extends the Activity End Date to 12/31/26. Changes include updated contact name, added use of acetone, added Mass spectrometers (JEOL, Kanomax, ThermoFisher etc.), removed several instruments, and removed the use of oil-based pumps.
