

Proposed Action Title: Operation of a 500 MHz NMR Spectrometer

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This activity relates to the operation of a shielded Avance NEO 500 Nuclear magnetic resonance (NMR) system. This system reads residual magnetism from samples after they are irradiated with radio waves (Megahertz)
