Proposed Action Title: Grouting Manhole P34 in F-Area

Proposed Action Description:

The proposed activity is to isolate the discharge pathway (Manhole P34) of industrial wastewater generated in F-Area Complex (FAC) from the 281-5F basin to the storm sewer that eventually discharges to the FM-3 outfall.
