Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Outdoor tests and experiments for the development, quality assurance, or reliability of materials and equipment (including, but not limited to, weapon system components) under controlled conditions. Covered actions include, but are not limited to, burn tests (such as tests of electric cable fire resistance or the combustion characteristics of fuels), impact tests (such as pneumatic ejector tests using earthen embankments or concrete slabs designated and routinely used for that purpose), or drop, puncture, water-immersion, or thermal tests. Covered actions would not involve source, special nuclear, or byproduct materials, except encapsulated sources manufactured to applicable standards that contain source, special nuclear, or byproduct materials may be used for nondestructive actions such as detector/sensor development and testing and first responder field training.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Nth Cycle Incorporated for the development, fabrication, and testing of an electroextraction unit for copper recycling. Project activities would include research, development, data analysis, laboratory operations, and outdoor testing.

The electroextraction unit would be designed, developed, and fabricated at Nth Cycle in Burlington, MA. Testing of the commercial pilot version of this unit would occur at various recycling centers in Michigan run by Padnos (headquartered in Holland, MI). Recycled copper materials would be sent to Oak Ridge National Laboratory in Oak Ridge, TN, for evaluation and testing.

All project activities would be completed in existing, purpose-built facilities. No facility modifications, new permits, or licenses would be needed to perform project activities. Potential hazards include the handling of chemicals, acids, and metals. Award recipients would adhere to established health and safety policies and procedures when performing project work, and would observe all applicable federal, state, and local health, safety, and environmental regulations.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS
