Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Electric Power Research Institute, Inc. (EPRI; Palo Alto, CA) to evaluate the effects that dim, flickering, and stroboscopic ultraviolet (UV) lights have on bats. The project aims to determine which UV lights would act as deterrents and prevent bat fatalities at wind turbine sites.

This NEPA Determination (ND) only applies to Budget Period (BP) 1 activities and does not apply to BP2 activities. DOE will complete the NEPA review for BP2 when sufficient information is available to conduct a meaningful review. Sufficient information includes a finalized study plan and field-testing site.

Award activities would be limited mostly to intellectual, academic, and analytical activities with exception to work proposed on the UV lights. EPRI's electrical engineering staff at their Charlotte, NC location would build, install, and test a timer/controller for the existing UV light setup. Along with EPRI, Bat Conservation International (Austin, TX), University of Colorado at Colorado Springs (Colorado Springs, CO), and the National Renewable Energy Laboratory (Golden, CO) would contribute to BP1 planning activities. All facilities are preexisting purpose-built facilities for the type of work to be conducted for this award. No facility modifications would be required.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.
