Proposed Action Title: 773-A D-Wing: Replace HVAC Units

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This work will include replacement of two existing rooftop packaged HVAC units, located on the 773-A D-Wing roof. The Design Authority Engineer (DAE) has requested that these units be replaced due to extensive maintenance history, repair and expense. The units will be replaced with equivalent like-for-like packaged HVAC units. Rev1. Replace HVAC unit HVAC-ACU-209015. Rev 2 Replace HVAC-ACU-D4. Rev 3. Replace HVAC unit HVAC-ACU-D2.
